Should you choose to join us as a client, we will manage a diversified, continually rebalanced portfolio of securities and collective investment schemes on your behalf. Algebra is a part of Farringdon Group Ltd and regulated under the name Farringdon Group Ltd in the federal territory of Labuan in the country of Malaysia. Any reference to this agreement to Algebra will be deemed to apply to Farringdon Group Ltd as well.

When you use our website and mobile applications you enter into a series of legally binding agreements.

You also agree to our Privacy Policy which covers how we collect, use, share and store your personal information.

### Agreement

When you access our website at [www.algebra2u.com](http://www.algebra2u.com) and/or our mobile applications ("our website" (which includes our blog), "our app" or "ALGEBRA") as a User, you're agreeing to be bound by the following Terms of Use, and, if you've choose to become a Client, our Client Agreement.
